WHAT TO DO IF YOU DO NOT HAVE AN ID AT ALL?

OPTION 1



Ask a poll worker for a reasonable impediment form and cast your ballot at your polling location

OPTION 2



Get a free ID at the DMV or County board of elections. Go to VoteRiders.org and contact Vote Riders if you need support getting an accepted ID for free.

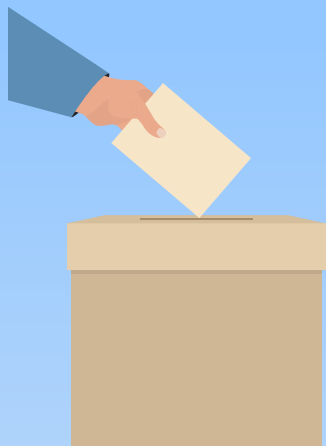

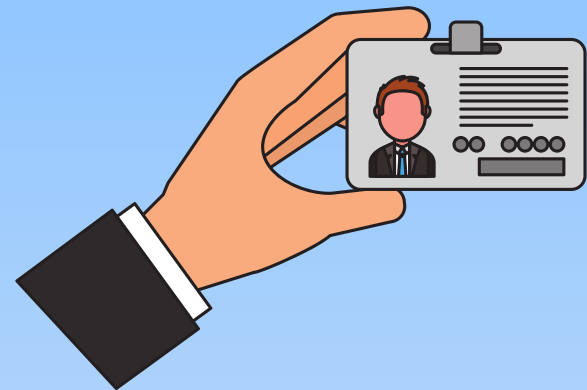
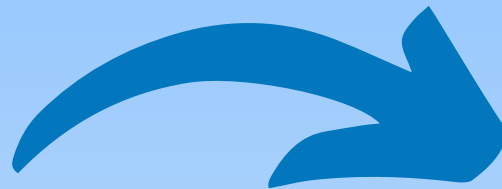

Ask a poll worker for a provisional ballot and cast your provisional ballot at your polling location
